Lt. Col. Todd Daniels currently serves as the Commander of 5th Battalion, 4th Air Defense Artillery Regiment, 10th Army Air and Missile Defense Command. He was commissioned a Second Lieutenant in the Air Defense Artillery from the Texas Tech University Army ROTC Program in 1999.

Lt. Col. Daniels served in a variety of assignments. Upon completion of the Officer Basic Course and the Short Range Air Defense Weapon Track at Fort Bliss, TX, he was assigned to 1-4 ADA, 1st Armored Division in Wackernheim, Germany where served as an Avenger Platoon Leader, a Bradley Stinger Fighting Vehicle Platoon Leader and Battery Executive officer. In August 2002, he was selected to serve in the 1st Armored Division G3 in Wiesbaden, Germany and as a G3 Battle CPT in Baghdad, Iraq. After the Captains Career Course, he served as an assistant BDE S3 in 31st ADA BDE FT Bliss, TX where he worked on the Counter Rocket Artillery Mortar fielding team. From 2005-2007 he commanded HHB/3-2 ADA FT Bliss, TX. Following Battery Command, he served as the Executive Officer of a Military Transition Team (MiTT) at Al Kasik, Iraq from 2007-2008. He then served as the Assistant Professor of Military Science, Recruiting Operations Officer, and Satellite Campus OIC at Auburn University Montgomery and Troy University, AL from 2008-2011.

Upon completion of Intermediate Level Education at the Command and General Staff College, he served as the 1-44 ADA BN Executive Officer at FT Hood, TX and Kuwait from 2012-2014. He then moved to Schriever Air Force Base, Colorado Springs, CO where he served as an Integrated Missile Defense Watch Officer and Watch Commander, Chief of Plans, and Chief of Allied Integration for Joint Functional Component Command-Integrated Missile Defense. His Operational Deployments include: Operation Iraqi Freedom, Baghdad, Iraq 2003; Operation Iraqi Freedom, Al Kasik, Iraq 2007-2008; Operation Enduring Freedom and New Dawn, Kuwait 2013-2014.

His awards and decorations include the Bronze Star Medal, the Defense Meritorious Service Medal, the Meritorious Service Medal (2 OLC), the Army Commendation Medal (3 OLC), Army Achievement Medal (4 OLC), National Defense Service Medal, Iraqi Campaign Medal (3 Campaign Stars), Global War on Terror Expeditionary Medal, Global War on Terror Service Medal, Army Service Ribbon, Overseas Service Ribbon (Numeral 4).
